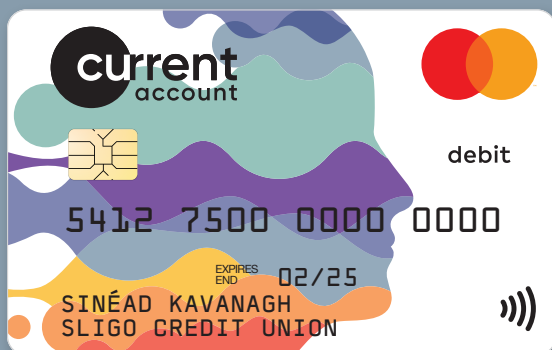

The ACE Current Account is available from age 12 to 16 years and comes with a debit card and mobile app. Plus, avail of FREE Instant Payments from one Sligo Credit Union account to another. Instant payments can be made from a Shares or Current Account.

The mobile app offers account controls, so rest assured they are in safe hands. The contactless Mastercard Debit Card can be used in shops, online and at any ATM. Accounts can be opened by Members aged 12 and over with Parental Consent required for Members aged under 16 years. The consent must be completed at the time of application by either the parent or guardian.

## Member Sign-Up

- Photographic ID: Original Minor's birth certificate is mandatory. If the Minor has a passport as well as a birth certificate, we ask you bring this also. The Parent(s) or Guardian(s) will also need proof of I.D.
- Address: Parent(s)/ Guardian(s) utility bill, government letter or bank statement dated within the last 6 months. Please ensure you have your Eircode with you.
- Membership Number: For both the Minor and the Parent(s)/ Guardian(s)
- The Minor Opening the Account will need: (i) an email address and (ii) a mobile phone number. Parent(s) / Guardian(s) email addresses or mobile numbers cannot be used.

### How will Applications be Received?

Application for the ACE Current Account must be made by members in-house in one of our branches - Wine Street, Sligo, Collooney, Co. Sligo or Drumkeerin, Co. Leitrim.

### Important Information

In order for you to open an ACE Current Account, you must be a member of Sligo Credit Union and resident in the Republic of Ireland. Parental consent is required in all cases. There are no joint accounts available or overdraft facilities. Terms and conditions apply
